WAIVER, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

(WARNING: By signing this agreement, you give up the right to sue for any injury or damage howsoever caused).

I, _____, of _____, Alberta, hereby sign this (Participant/Parent or Guardian) Agreement on behalf of myself, my son/daughter _____, my personal representative, heirs and assigns.

- I agree as a precondition to my son/daughter participation in Okotoks BMX Club and related activities organized and conducted by the Okotoks BMX Club allowing my son/daughter to do so, to be strictly bound by the terms of this Waiver, Assumption of Risk and Indemnity Agreement (hereinafter referred to as the "Agreement").
- I acknowledge that involvement in the Okotoks BMX Club and activities related thereto involve Inherent risks that may cause serious injury and possibly death to participants. I further recognize that Okotoks BMX Club and activities related thereto may involve additional risks and dangers unforeseen.
- I fully understand the risks and dangers associated with my son/daughter participating in BMX racing and related activities and accept same entirely at my own risk.
- I hereby waive any and all claims which I, my son/daughter, personal representatives, heirs or assigns may have against Okotoks BMX Club from all liability for injury, death, property damage or any other loss sustained by myself, my son/daughter, personal representative, heirs or assigns as a result of my son/daughter participation in the Okotoks BMX Club and related activities due to any cause whatsoever including without negligence on the part of Okotoks BMX Club. I further agree to indemnify Okotoks BMX Club for any and all legal fees (on a solicitor and his own client basis) or costs which may be incurred in defending any lawsuit or claim which may be brought against them.
- I appreciate that this Agreement applies whether Okotoks BMX Club is at fault or not and it limits the liability of the Okotoks BMX Club to the same extent as it limited the liability of any person associated with the Okotoks BMX Club even though these persons are not formal parties to this Agreement. I understand that Okotoks BMX Club in securing execution of this Agreement by myself on behalf of myself, my son/daughter, personal representatives, heirs or assigns, is acting as agent or trustee on behalf of or for the benefit of Okotoks BMX Club who shall to this extent be or be deemed to be parties to this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT. I UNDERSTAND THAT THIS DOCUMENT CONTAINS A PROMISE NOT TO SUE OKOTOKS BMX CLUB OR THEIR SUCCESSORS OR ASSIGNS, AND A RELEASE OF INDEMNITY FOR ALL CLAIMS.
